As an entrepreneur, Ms. Hines is the former co-founder/owner of (ASIC) American Skyline Insurance Co., a Property & Casualty Company that provided small business, homeowners and automobile insurance to the under served urban markets in the greater Baltimore and Washington DC communities. In 2000, after the founders raised over \$10 million in initial capital, they launched the sole minority owned Property & Casualty company in the USA, employing over 100 people and servicing over 10,000 customers. Prior to her entrepreneurial venture, she held executive and senior level management positions at American Skyline Insurance Co., USF& G Insurance Co., Allstate Insurance Co., and FILA USA. In her corporate career, she had underwriting management oversight for businesses with over five hundred million dollars P & L in the states of Ohio, Kansas, Missouri, Oklahoma, Nebraska, Iowa, Colorado, Utah, Wyoming, Idaho,& Montana; Corporate Relations & Human Resources oversight for 2 R & D's and design center in Oregon, Massachusetts & New York; and multi million dollar insurance operations in MD & DC.

Ms. Hines corporate business accountabilities jettisoned her decision to become a serial entrepreneur. Currently as a Business Development Consultant, her clients have had diverse businesses in the area of electronic recycling, electronic medial records, graphic design work and wellness products. Today she primarily represents businesses in need of commercial insurance and women entrepreneur businesses. She serves as Chair for the Baltimore Chapter I & II of Women Presidents Organization and recently will co-host a radio talk show twice a month on WEAA 88.9 FM called W.O.M.E.N (Women Owned & Managed Entrepreneur Network) to discuss successful women entrepreneur businesses. In addition, she's becoming a frequent participant at the White House and on telephone conference calls discussing Women Business Briefings & Updates.

Philanthropy plays a significant role in Ms. Hines's life. She serves on numerous non profit boards and continues to demonstrate her leadership by participating on some of
